





1. M/ PACESS WELLNESS INDIA LLP ("THE LLP") is a Limited Liability Partnership incorporated as per The Limited Liability Partnership Act, 2008 on the 7th day of July 2022 with LLPIN: ABB-6239 under an LLP Agreement dated 21st day of July 2022, hereinafter referred to as THE PRINCIPAL LLP AGREEMENT.
2. The Continuing Partners (First Party to Sixth Party) are carrying on the business relating to the trading of Pharma and Health Care products, under the name and style Pacess Wellness India LLP having its registered office at Kerala.
3. The Partners of the LLP are desirous of altering the existing objects of the LLP and step into direct selling business to achieve more business avenues for the LLP.
4. The New Partners (Seventh Party to Twenty Sixth Party) are desirous of being admitted as new partners in M/s. Pacess Wellness India LLP and the Continuing Partners (First Party to Sixth Party) of the LLP are willing to admit them as New Partners.
5. Therefore, the Continuing Partners of the LLP have agreed to amend the PRINCIPAL LLP AGREEMENT dated 21st day of July 2022 and reduce in writing to this First Supplementary LLP Agreement for altering the Object clauses, admitting new Partners by altering the PRINCIPAL LLP AGREEMENT.

NOW IT IS AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. The Agreement is supplementary to and an essential part of the PRINCIPAL LLP AGREEMENT on the terms of which the mutual rights and duties of the partners and their rights and duties in relation to the LLP are determined.
2. Objects clause 6, 6.1, 6.2, 6.3 and 6.4 in the Principal LLP agreement shall be replaced with the new object clauses as stated below.
 - 6.1 To establish and develop a direct selling business, to provide high quality consumer products, personal care, nutrition, commercial, general merchandise, wearing apparels, appliances, cosmetics, and allied items directly to consumers through independent distributors/direct sellers or any other product or services. The LLP will not engage in any restricted business activities in accordance with Indian law, including pyramid schemes and money circulation schemes
 - 6.2 To establish, setup, marketing networks, wholesale/ retail outlets, franchisee showrooms, online website stores, virtual store(s) including chain stores, modern retail stores, electronic commerce platform, online / virtual marketplace in all its forms and to carry on the business of setting up of network infrastructure including storage, movement, delivery of goods and services for trade and commerce arrangements with distribution agencies, network marketing, direct selling electronic channels for the business of the Company and to act as marketing consultants in establishing of marketing network(s), Direct selling networks.
3. The Continuing Partners (First Party to Sixth Party) have increased their individual contribution from Rs 1,00,000 to Rs 5,00,000 in the LLP.
4. The Seventh to Twenty Sixth Party shall be appointed as New Partners of the LLP and their contribution shall be as stated in Schedule -1 annexed to this LLP Agreement.
5. The revised Capital of the LLP shall be Rs 56,00,000 (Rupees fifty six lakhs only) to be contributed by the Partners as specified in Schedule -I hereto.
6. The admission of Partners and increasing of Capital of the LLP shall be notified to the Registrar of Companies, Kerala.

7. the Contribution of each Partners shall be as stated in SCHEDULE I annexed to this agreement the same shall replace the SCHEDULE I to the PRINCIPAL LLP AGREEMENT
8. The Clause No 23 Sharing of Profit and Loses in the Principal LLP Agreement shall be replaced with the below clauses.

23. Sharing of Profit and Loses.

The net profit or Loss of the LLP (profit after tax) shall be divided among the parties as stated below.

23.1 The Fifth Party shall be act as the operation head of the LLP and he shall be responsible for the marketing, promotions and management of the business of the LLP. He has the special rights to appoint necessary staff in the LLP with the consent of Designated Partners. The total profit payable to the fifth partner shall not be greater than 20% of the Net Profit of the LLP. The Fifth Partner shall share the loss of the LLP at 20%. In addition, Fifth Partner is entitled to a monthly remuneration of Rs 1,00,000/- (One Lakh per month) from the revenue generated by him and team of the LLP.

23.2 The Designated Partners (First, Second, Third, Fourth and Sixth Partners) shall share the net profit or loss at 20% among themselves.

23.3 The remaining 60% of the net profit or loss of the LLP shall be shared among all the Partners (First Party to Twenty sixth Party) on pro-rata basis.

THE PRINCIPAL LLP AGREEMENT shall as and from the date hereof be deemed to have been modified to give effect to this Agreement and subject to such modification shall remain in full force and effect.
